It is SKA-POW!'s policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to <https://ska-pow.com> (hereinafter, "us", "we", or "https://ska-pow.com"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

## Website Visitors

## Gathering of Personally-Identifying Information

## GDPR Privacy Policy of SKA-POW!

Last updated: Jan 01, 2019 Definitions

- SKA-POW! SKA-POW! means SKA-POW! LLC, Company's Information and Address.

- GDPR General Data Protection Regulation Act.
- Data Controller Data Controller means the natural or legal person who (either alone or jointly or in common with other persons) determines the purposes for which and the manner in which any personal information are, or are to be, processed.
- Data Processor Data Processor means any natural or legal person who processes the data on behalf of the Data Controller.
- Data Subject Data Subject is any living individual who is using our Service and is the subject of Personal Data.

## 1. Principles for processing personal data

Our principles for processing personal data are:
